DOHIF is a non-profit California corporation governed by a 15 member board of directors. DOHIF operates under a set of bylaws, and uses Roberts Rules of Order for parliamentary procedure. The DOHIF board of directors meets on the second Tuesday of every month except December, and on rare occasions when the Chairman calls a special meeting. Meetings generally last from 1 to 2 hours, depending on the agenda.

There are several standing committees including: Fund Raising, Finance and Building. Other committees may be appointed from time to time by the Chairman. Board members may volunteer to work on any or all of these committees.

The Foundation is funded through a combination of fund raising activities:

Events (Tractor Days, Mexican Dinner, Wine Tasting, Harvest Festival, etc)

Grants

Rent

Donations

Bequests

Mass Mailing

Other means of providing sustaining and capital improvement income are being continuously proposed and reviewed.

DOHIF needs – Board members are expected to:

- a. Attend all board meetings unless they notify the Chairman in advance.
- b. Participate in Fund Raisers. Board members may volunteer to perform any type of duties, including selling (tickets, food, etc), serving food, washing dishes etc. Board members are encouraged to arrange travel and personal schedules so they will be available to help with fund raisers, when possible.
- c. Have fun – it's not all work, but even the work is rewarding.
